Care Lodge has received a very generous donation from the proceeds of the barbeque. Please know that this gift means so much to our families staying at the shelter.

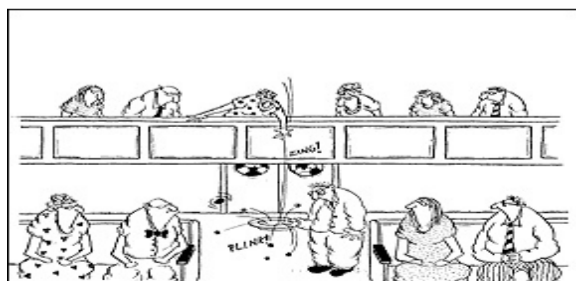
We appreciate the continued commitment to our mission of helping those in crisis. You are a very special church and we need your support and prayers.
